Anti-Ragging Policy

Introduction: - Ragging constitutes one or more of any of the acts such as;

- Any abuse by spoken words, emails, post, public insults which would also include deriving
 perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the
 discomfiture to fresher or any other student.
- Asking any student to do any act which such student will not in the ordinary course do and which
 has the effect of causing or generating a sense of shame, or torment or embarrassment so as to
 adversely affect the physique or psyche of such fresher or any other student.
- Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher.
- Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person.
- Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.
- Any conduct by any student whether by words spoken or written or by an act which has the
 effect of teasing, treating or handling with rudeness a fresher or any other student.
- Indulging in undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
- Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.

Specific Objectives:

- To prevent the occurrence of ragging by following the provisions of regulations in the institution.
- To provide punishment to those indulging in ragging as provided for in regulations and the appropriate law in force.
- To sensitize students to adopt measures that will prevent ragging.
- To absolutely prohibit ragging within the college campus.

- Conduct workshops or awareness programs against ragging menace and orient the students.
- To consider the complaints received from the students and conduct enquiry and submit report to the Anti- Ragging Committee along with punishment recommended for the offenders.
- Oversee the procedure of obtaining undertaking from the students in accordance with the provisions.
- To take all necessary measures for prevention of Ragging inside the Campus/ Hostels.

To offer services of counselling and create awareness to the students.
