### **Policy for Anti-Sexual Harassment**

- The aim of this policy is prevention, prohibition and redressal of sexual harassment of nonteaching or teaching women employees and student of the College. The Internal Complaints Committee is established in the college as per the norms of The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013, promulgated by the Government of India in December 2013. However, based on the aforesaid Act and Saksham report of MHRD, a new regulation was propagated by the UGC in 2016 termed University Grants Commission (Prevention, Prohibition and Redressal of sexual harassment of women employees and students in Higher Educational Institutions) Regulation, 2015, all educational institutes need to set up an Internal Complaints Committee.
- Hence, the Internal Complaints Committee (ICC) is established in Yogeshwari Mahavidyalaya, Ambajogai under the guidance of Dr. V. S. Hamde, Principal of College. The main aim of the ICC is to look into the complaints of sexual harassment occurred within the College campus and also to generate awareness about the issue. The act has outlined the constitution of the committees, the process to be followed for making a complaint and conducting inquiry into the complaint in a time bound manner.
- Sexual Harassment: An unwanted conduct with sexual undertones, persistent conduct which demeans, humiliates or creates hostile environment is termed as Sexual Harassment and it includes any unwelcome physical, verbal or non-verbal conduct of sexual nature; physical contact and advances.
- Any one of the following circumstances, if it occurs or is present in relation or connected with any behaviour that has explicit or implicit sexual undertones: -
- Implied or explicit promise of preferential treatment as quid pro or quo for sexual favours;
- Implied or explicit threat about the present or future status of person concerned;
- · Humiliating treatment likely to affect the health, safety, dignity or physical integrity of the person concerned;
- Creating an intimidating offensive or hostile learning environment;
- Implied or explicit threat of detrimental treatment in the conduct of work.
- Function of ICC: The Internal Complaints Committee is an educational complaint redressal mechanism for the members of faculty, staff and students of the College and its objectives are:
- To promote awareness about sexual harassment amongst students of both gender through educational initiatives that encourages and fosters a respectful and safe campus environment.

- To advice complainants of means of resolution as specified by the legislation.
- To ensure fair and timely resolution of sexual harassment complaints.
- To provide a neutral, confidential and supportive environment for teaching and non-teaching women employees and the students on the campus.
- Procedure: Any aggrieved woman or student may make, in writing, a complaint of sexual harassment at workplace to the ICC, within a period of three months from the date of incident. If she is unable to make a complaint in writing, the ICC will render all reasonable assistance to her for making the complaint in writing.
- If the ICC is satisfied that the circumstances were such, which prevented the woman from filing a complaint within a period of three months, it may extend the time limit not exceeding to the three months. The complainant needs to submit six copies of the complaint along with the supporting documents and names and addresses of the witnesses to the ICC. On receipt of the complaint, the Committee will send one of the copies to the respondent within a period of seven working days and ask the respondent to file his reply to the complaint along with his list of documents and names and addresses of witnesses, within a period not exceeding ten working days from the date of receipt of the complaint by him. Legal practitioner is not allowed to represent the case at any stage of the proceedings before the Committee.
- Punishment: If any student is found guilty, the student will be punished based on the severity of the offence. The student's privileges such as access to library, scholarships, allowances, and auditoria, halls of residence, transportation and identity card will be withheld. Also, the student will be suspended or restricted entry in College campus for specific period. Student may also be expelled or denied readmission in the College. Apart from disciplinary action which the ICC recommends to be taken against the guilty employee or student, the law also provides restitution to the aggrieved person for emotional trauma and losses incurred in the form of monetary compensation.
- Also any employee, if found guilty by the ICC shall be punished as per the service rules.
- Awareness programs of ICC in College:

For ensuring a safe and sexual harassment free environment in the College, every year the ICC has been organizing an awareness programme for the College students. Through these programmes the students are made aware of the UGC regulation, 2015 regarding sexual harassment and what sexual harassment actually means. They are also instructed to report any misconduct held against them in the College campus to the ICC verbally and in writing too.

However, until this date, no cases of sexual harassment have taken place in the College.
